In Chapter 26, we have added a discussion of the bullwhip effect on the cash forecast, as well as how it can be mitigated to achieve more accurate cash forecasts. Chapter 27, which covers the planning and control of receivables, has been substantially bolstered with new information about credit policies and procedures, the review and processing of credit applications, granting credit, credit insurance, creating and delivering invoices, collecting cash, and managing the credit and collections staff. Chapter 28, which covers the planning and control of inventory, has been enhanced in a similar manner. It now includes in-depth discussions of the best ways to conduct inventory purchasing, receiving, storage, picking, and shipping.
