Comparing Investment vs. Commercial Banks

Owning real estate can be considered an investment because it's possible to build equity over time as well as earn a return on investment from any rent received. Mutual Funds. A mutual fund can be thought of as a "basket" of investments. Mutual funds provide investors with access to a pool of investment options (e.g. bonds, stocks, equities).

The Investment Answer

If the investment comes from a designated Canadian venture capital fund, you must secure a minimum investment of \$200,000. If the investment comes from a designated Canadian angel investor group, you must secure a minimum investment of \$75,000. You don't need to secure a financial investment from a business incubator.

Investment capital

A Ponzi scheme is an investment fraud that pays existing investors with funds collected from new investors. Ponzi schemes are named after Charles Ponzi. In the 1920s, Ponzi promised investors a 50% return within a few months for what he claimed was an investment in international mail coupons. Ponzi used funds from new investors to pay fake “returns” to earlier investors.
